## SEMI-TRUCK AND TRAILER PARKING RULES AND REGULATIONS

- 1. A parking area on Township property along Water Street near the East Lake Road intersection is established for semi-trucks and trailers, subject to the following Rules and Regulations.
  - A. A "**Parking Permit**" tag issued by the Township will be required and must be posted in the front window of the vehicle when the vehicle is parked in the parking area. The tag must be posted to allow clear sight of the tag when it is placed in the window area. The Permit must be renewed annually by January 1.
  - B. A copy of the driver's license will be submitted with the application.
  - C. All vehicles will be parked in a designated area on the north portion of the lot as indicated by signs.
  - D No vehicles will be permitted to be parked longer than seventy-two (72) consecutive hours.
  - E. The owner/operator of the vehicle will sign a waiver form absolving Lawrence Park Township of any liability to the vehicle or driver.
  - F. The owner/operator will be responsible for any spillage of fluids and proper clean-up of any spillage.
  - G. Permission to park may be revoked by Lawrence Park Township at any time without cause.
- 2. When out on a run, your personal vehicle can be left in the parking lot until your return home.

## However, you must take the parking permit tag from your semi truck and place it in your personal vehicle while parked in that lot.

# If the tag is not left in the window of your personal vehicle, the vehicle can be ticketed or towed.
