656.03-EXCESSIVE NOISE

To restrictive, Dennis suggestion is to add automobiles (any vehicles)

Propane, illegal to store in house

Rental units, we have the authority to go in and check on ordinance violations, homes owned by person living there we have no authority, but if neighbors sign that they witness a violation then we are authorized to enter. Ordinances on vehicles- need to add current inspection and license. Waste Mgmt. stated the biggest thing they see are foxes and coyotes. Penalty phase if not planning commission responsibility. Code enforment officer felt we should start doing rental inspections.
