

Minutes March 5, 2017 Recreation Board Meeting

Also planned for the Fourth of July is the Bike Parade and Smith's Hot Dogs will be sold at a discount for the Bike Paraders.

Ms. Benovic said the Gazebo concerts in Beute Park will be every other Wednesday and that there was no way these concerts could avoid conflicting with some other concert series. She said the Harborcreek concerts will be every Wednesday, Eight Great Tuesday will be every week on Tuesday, and weekly street dances in the city will be every Thursday. Concerts would not work on Monday, Friday, Saturday or Sunday nights. Bands and dates will be posted on the Township website when determined.

Ms. Benovic said the invitations to the Fourth of July parade are out and it is too soon for replies.

Kelly Majczyk reported on the Little League. She said that it is early yet. She said that numbers were down for both the boys and girls enrollments and while there were enough boys, the girls' numbers were still too low.

Ms Majczyk moved for adjournment and Tom Roberts seconded the motion, the vote was unanimous and the meeting ended at 8:14 pm.

Boat Ramp--

The recreation board found the beach particularly clean and the only issue was a tire left near the Waste Management Tote but Jim Van Dyne suggested that this may have washed up onto the beach and someone brought it up to the trash can.

Lake Cliff Park--

It was noted that on the oldest remaining pieces of equipment, there remains a damaged tunnel which is about six feet off the ground that was slated for replacement three years ago and there was supposed to be a replacement section in storage at the township garage. Someone said that it turned out that the section did not fit. As the piece is dangerous, it is to be removed. Phone numbers on the label on the equipment were noted with the hopes of tracking down replacement parts. "Play World Systems 1-800-233-8484 and RPI004500796".

It was also noted that the mulch which was used as a cushioning material around the equipment is in need of replacement. Board members noted that all picnic tables are intact and present and still chained to the facilities. There is little graffiti this year.

Napier Park--

Discussion on delayed remodeling of Napier Park – money was used in Teker Park improvements and new grants planned.

A slide on one piece of the equipment was broken and dangerous; this was noted for removal if a replacement could not be located. On the orange "spider" piece, several bolts had worked loose and need tightening. On the piece dubbed "The Circus Tent" some bolts were missing. Tammy Benovic said that the picnic tables need freshening-up.
