~ Bud Hughes spoke to the Board about the Shade Trees and the fact that they need pruning. He offered to walk around and trim those trees to code if the Maintenance crew could come pick up the branches. He also addressed the Board asking if a Beautification Ordinance could be put into effect with property owners being made to retain insurance so that we don't have another situation like the burned out row homes. Bud thanked the Board for their concern for the footbridge. Hughes also said that the Maintenance guys are doing a great job on the streets and that they are taken care of better in these past 2 years than they have ever been.~

~Dale Durst thanked the Board for placing a new sign at the boat launch. Durst also asked if caution tape could be placed around the burned home on Harvey as children are beginning to go up to the house. Dale stated that there are a couple of pot holes at the corner of Cabot/Harvey and asked if they could have some cold patch placed in them. small ones with cold patch because it does not stick due to the weather and when the plow trucks hit it then it just breaks away, but he would have the guys take a look at it and see if there is something they could possibly do.~
