Soudan Lift Station

- PA DEP WQM Target date for issuing the permit is July 20th. Received one comment, via email correspondence. The comment requested an updated Pennsylvania Natural Diversity Inventory (PDNI) search, which required additional coordination with AP Fish & Boat Commissioner. A clearance letter is anticipated shortly and will be forwarded to the Department once obtained. Once the Department receives the clearance letter, they will issue the WQM permit. LPT granted Adam Pesek, PA DEP WQM Division, permission to transfer electronic copies of permit documents to expedite the process.
- USDA Ongoing coordination to address USDA review comments, resolve administrative and contract document comments, including limited technical comments. Awaiting updated cost estimates and non-proprietary technical specifications from W.C. Weil Company (lift station manufacturer representative), as requested by USDA.
